COMPLETE TOURNAMENT RULES ON BACK OF FORM SANCTIONED BY N.D.B.C.

SOUTHSIDE BOWL "KING OF THE HILL" TOURNAMENT RULES

- 1. THE MARVIN AND MICHAEL SHUPP MEMORIAL HANDICAP KING OF THE HILL TOURNAMENT IS OPEN TO ALL CURRENT N.D.B.C. CARD HOLDERS. CARDS MUST BE PRESENTED AT CHECK IN—THIS IS A REQUIREMENT, NO CARDS-NO BOWLING.
- 2. THE TOURNAMENT HANDICAP IS 80 PERCENT OF 150.
- 3. AVERAGE USE WILL BE HIGHEST BOOK AVERAGE FOR 2017-2018 SEASON. IF NO AVERAGE IS IN THE BOOK, THE BOWLER WILL USE THEIR HIGHEST AVERAGE FOR THE 2018-2019 SEASON. PROOF OF AVERAGE MUST BE PRESENTED. IF NO AVERAGE VERIFICATION PRESENTED, THEN BOWLER WILL BOWL SCRATCH.
- 4. EACH BOWLER WILL BE RANDOMLY ASSIGNED A STARTING LANE.
- 5. EACH BOWLER WILL BOWL SIX (6) GAMES IN QUALIFYING. BOWLERS WILL CHANGE LANES AFTER EACH QUALIFYING GAME.
- 6. THE TOP FIVE (5) TOTALS FROM QUALIFYING WILL BOWL IN STEPLADDER FINALS (PRO STYLE FORMAT). IF THERE IS A TIE THAT WOULD RESULT IN MORE THAN FIVE (5) QUALIFIERS, A 9TH AND 10TH FRAME WILL BE BOWLED BY EACH TIED BOWLER TO DETERMINE STARTING POSITION. THE SAME METHOD WILL BE USED TO BREAK ALL TIES FOR STEPLADDER FINALS.
- 7. THE PRIZE FUND WILL BE RETURNED 100 PERCENT THE DAY OF THE TOURNAMENT.
- 8. TARDY BOWLERS WILL NOT BE PERMITTED PRACTICE BALLS AND GIVEN A ZERO FOR EACH FRAME MISSED.
- 9. IN ORDER TO ELIMINATE CONFUSION THE DATE OF THE TOURNAMENT, EACH ENTRY MUST BE ACCOMPANIED BY THE ENTRY FEE. THOSE PAYING DAY OF TOURNAMENT WILL BE CHARGED THE WALK-IN FEE OF \$30.00. THERE WILL BE NO REFUNDS!
- 10. ANY BOWLER FALSIFYING AVERAGE FORFEITS ALL RIGHTS TO ANY TOURNAMENTS PRIZES AND FEES AND WILL BE SUBJECT TO SUSPENSION BY N.D.B.C.
- 11. TOURNAMENT MANAGEMENT HAS THE RIGHT TO REFUSE ANY ENTRY.
- 12. DUE TO INCLEMENT WEATHER, WE RESERVE THE RIGHT TO POSTPONE THE TOURNAMENT.
