FORMAT. ELIGIBILITY AND GENERAL RULES

1. Format of Tournament:

- a. Qualifying event will be held at T-Bowl Lanes and Victory Lanes. This will be a 3 game event with handicap. There will not be any shifts, bowl as lanes are available. Dates and times listed on flyer front.
- b. The top five (5) bowlers from each house will roll-off on March 30, 2019, (no extra fee/lineage to qualifiers) for positions 1 through 10. The 6th place finisher from each bowling alley will be considered as the alternate in case one of the qualifiers are unable to come. Finals will be a 4-game roll-off. Bowlers will switch lanes after each game. The final roll-off will alternate bowling centers beginning this year.
- c. A bowler is eligible to bowl in one or both establishments to qualify for roll-off. A bowler can only qualify in one house. If said bowler bowls in both houses, bowler's highest qualifying score will be used. There will be five bowlers representing each bowling establishment. If you qualify and are not able to roll off, you will be placed in last position.
- d. If there is a tie for places 1-4, the position will be determined by a coin toss. If there is a tie for 5th place, the bowler advancing will be decided by a 1 game roll off to be completed within 3 days of the conclusion of the tournament at that bowling alley.

2. Eligibility Requirements:

- All events of this tournament are open to sanctioned residents of the State of Virginia and current sanctioned members of the Virginia Ladies All Star Tour.
- b. Entrance averages: A bowler's entrance average will be based on 21 games or more and be determined as follows:
 - (1) Highest 2016-2017 winter league sanctioned average or if, none,
 - (2) Highest 2015-2016 winter league sanctioned average or if none,
 - (3) Highest 2014-2015 winter league sanctioned average or if none,
 - (4) Highest current 2018-2019 winter league sanctioned average as of March 1, 2019 (minimum of 12 games) or if none,
 - (5) Any Virginia Ladies All Star bowler not meeting the requirements under (1), (2), or (3) above, will use VLAS average for 2017-2018 (minimum of 12 games) or if none,
 - (6) Bowler's average shall be 160 (for the purpose of figuring handicap).
- c. If a bowler has to quit during a game, the bowler will receive 1/10 of their average per frame for the rest of the game. This is based on the NDBC rule book guidelines.
- d. All bowling balls may be weighed and measured prior to entering the tournament and may be checked at any time during or after use in any event of this tournament.
- e. No warm-up bowling against pins shall be allowed by bowlers prior to any event of this tournament
- f. All entrants must be sanctioned by NDBC. If bowler is not a member of Virginia Duckpin Bowling Association, said bowler must provide current sanction card.
- g. Expenses covered will include but not be limited to the following: tournament sanction fee, director's fee, and postage.

3. Handicap Rules

a. Handicap shall be 80% from the average limit. Handicap is unlimited.
